@Corey Hardinger (re: PIT count): Great question. The PIT count continues to be an important reflection of what is happening in CoCs with regard to homelessness. The PIT count is just one of many of the system performance measures that we look at and we score it similar to many of the other measures. Additionally, we give CoCs space in the CoC Application (question 2B-4) to talk about what is driving change and we consider those responses for the purpose of making final score determinations.

@Hannah, thanks for your question. We understand that for some CoCs reallocation is more challenging to implement. Our scoring actually provides two different ways to get full points for the reallocation rating factor. One is showing that the CoC has reallocated at least 20% of their funding over the past several years, and the other is that the CoC is running a local selection process where they actively review the performance of existing projects and have a standard process for reallocating projects. That doesn't mean that the community will necessarily do any reallocation, but the CoC should always be looking for opportunities to reallocate and replace lower performing projects with higher ones.

It is for all CoCs to describe changes. We are looking at what your CoC is sharing regarding what drove changes and an explanation about why those factor impacted the PIT count. We may provide some (though minimal) points for those explanations.

@Mitchel Blum-Alexander--a quick follow up to your question. If you reallocate a DV project, as Ebony noted, you will have to fill out a new project application, but you will not have to fill out the DV Bonus questions in the CoC Application. Your project is being proposed for funding under reallocation rather than under DV Bonus, so the DV Bonus questions are not required. We will discuss in Q&A.

@Corey we are a rural CoC that has a hard time losing these points as well. Our region is seeing an increase overall in eviction rates and folks in homelessness AND we have drastically increased our outreach efforts with the new team in place. in FY2022, our 12-county outreach had 2,500 service transactions while our FY23 had over 11,000 services in our 12-county outreach and FY24 is averaging 4,000 services a month. We are gaining traction in counties we have never been able to even get a PIT count in before through increase out outreach which has drastically increased our PIT as well. It is frustrating to put in the work to get a much better representation of homelessness in our community and lose points because we have improved our methodologies

For the TH-RRH new project application rating factors, can HUD provide more information on the 2-point factor, specifically the last option? The proposed project will provide enough rapid rehousing assistance to ensure that at any given time a program participant may move from transitional housing to permanent housing. This may be demonstrated by identifying a budget that has twice as many resources for the RRH portion of the project than the TH portion, by having twice as many PH-RRH units at a point in time as TH units, or by demonstrating that the budget and units are appropriate for the population being served by the project.
