EXTENSION OF TIME FOR WRITTEN DETERMINATION

On May 13, 2022, the Office of Hearings and Appeals issued a Ruling on Respondent's and Government's Dispositive Motions and Initial Decision in the above captioned case. On June 10, 2022, Respondent, Housing and Redevelopment Insurance Exchange (HARIE), filed an appeal of the Ruling on Respondent's Dispositive Motions and Government's Dispositive Motions and Initial Decision. On June 30, 2022, the Government filed a brief in opposition to the Respondent's appeal. Under 24 C.F.R. § 26.26, the Secretary, or her designee, shall issue a written determination within 30 days after receipt of the appeal. Currently, the written determination is due on July 10, 2022. The Secretary, or designee, may extend the time in which a written determination must be issued by an additional 60 days for good cause shown in a written justification issued to the parties.

In its appeal, Respondent has raised four separate justifications for overturning the Initial Decision and Order. In addition, there is delay in obtaining the hearing record from the Office of Hearing and Appeals. Because of the number of issues being raised on appeal by Respondent and delay in receiving the record from the Office of Hearing and Appeals, I extend the time in which a written determination shall be issued by 60 days and the new deadline is now September 8, 2022.
