ORDER GRANTING MOTION TO DISMISS

This matter is before the Court upon Respondent's March 21, 2023, request for a hearing concerning an administrative action proposed to be taken against Respondent by the U.S. Department of Housing and Urban Development ("HUD"). On March 23, 2023, the Court issued a *Notice of Hearing and Order* scheduling an expedited hearing to take place on April 17, 2023, pursuant to 12 U.S.C. § 1708(c)(4) as implemented by 24 C.F.R part 25.

Since that time, the Court granted several of the Parties' motions to stay the proceedings based upon the matter being in various stages of settlement. On July 7, 2023, HUD, with consent of Respondent, filed a *Notice of Settlement and Motion to Dismiss*, explaining that on July 6, 2023, the Mortgagee Review Board executed a settlement agreement resolving the allegations in the February 24, 2023 Notice of Withdrawal, which was the basis for the present matter. HUD further explained that both Parties had executed the settlement agreement and asked that the Court dismiss the matter.

For good cause, the *Notice of Settlement and Motion to Dismiss* is **GRANTED**, and this matter is dismissed with prejudice.
