Upon approval, PHAs are required to submit the board budget approval to HUD through form HUD-52574 by the HUD-specified deadline (refer to the table). For submittals related to the CY 2024 Op Sub (which is the PHA's FYE in 2023), PHAs may either use (1) the form in the Board Resolution module within the Public Housing Portal, the method recommended by HUD or (2) the form from HUDCLIPS. If the PHA chooses to use the form from HUDCLIPS, the PHA then must upload that form in the Board Resolution module. In some cases, PHAs with FYE 3/31, 06/30, and 09/30 may have already created a Board Resolution and signed manually for the year ending 2023 (which are the Board Approvals related to the 2024 Op Sub). HUD does not pre-populate data for AOS MTWs like other PHAs. Therefore, these PHAs can calculate their eligibility almost entirely independent of the publication of the form HUD-52723. The AOS MTW PHAs should calculate their Op Fund grant eligibility before HUD publishes the form HUD-52723s and then complete and submit their form HUD-52723, along with supporting documentation, promptly after HUD publishes the Excel tools. More specifically, PHAs should submit their calculations of Op Fund grant eligibility to their FO, along with any supporting documentation, by October 30, 2023. This will give HUD more time to review these submissions, which is needed to ensure accurate funding because of the complexity of the AOS calculation.
