Happy New Year! I want to let you know how much I appreciate your patience during the longest government shutdown on record. Our dedicated staff are back at work and working diligently to follow up on your emails and our daily book of business to ensure we are responsive to your needs. During a national staff meeting today our regional offices shared stories on the impact the shutdown had on our tribal communities and the many critical items that we were unable to address that prevented you from doing your work. Please know that we are working to address the challenges created by a loss of one month of work.

Today I am pleased to announce that the President signed a FY2019 funding bill that funds ONAP through September 30, 2019. Highlights from the funding bill are as follows:
