There were additional columns added to this spreadsheet to reflect the changes to the IHBG Formula regulations. The new columns affected by the new regulations are as follows:

Unadjusted FY 2024 Allocation: This column is equal to the appropriation plus the net amount of repayments collected in FY 2024 plus the carry-over amount minus three million dollars unused for the minimum allocation. In FY 2024, the amounts are \$1,111,000,000 + \$1,963,302 + \$6,473,015 - \$3,000,000 which totals \$1,116,436,317.

FY 2024 Undisbursed Funds Adjustment (24 CFR 1000.329): Section 1000.342 requires an Undisbursed Funds Factor (UDFF) be applied to tribes with an initial allocation of \$5 million or more, and with undisbursed IHBG funds in the Line of Credit Control System (LOCCS) on October 1 in an amount greater than the sum of the prior 3 years' initial allocation calculations. In FY 2024, there were no Tribes that exceeded the LOCCS limitation. Therefore, no adjustments were made pursuant to this section.

Minimum Allocation Adjustment (24 CFR 1000.329): In accordance with §1000.329, HUD will hold the lesser amount of \$3 million or available carry-over funds for additional allocations to tribes with grant allocations of less than 0.011547 percent of that year's appropriations. In FY 2024, \$3 million in eligible carry-over is available. However, this was not enough to increase all eligible Tribes to a minimum allocation of \$120,287 (0.011547 percent of this fiscal year's appropriations). The regulations at 24 CFR § 1000.329 specify that if the set-aside carry-over funds are insufficient to fund all eligible Tribes at 0.011547 percent of that fiscal year's appropriations, the minimum total allocation shall be reduced to an amount which can be fully funded with carry-over funds.

FY 2024 Final Allocation: This column is equal to the appropriation plus the carry-over amount. In FY 2024, the amounts are \$1,111,000,000 + \$6,473,015 which totals \$1,117,473,015.

Please note that the totals may differ slightly due to rounding.
