

# Reminder for Moving to Work Agencies - Quarterly Reporting of Commitments and Obligations in VMS

## VMS Data and Year-End Reporting Deadline

Reminder to all PHAs, that the year-end reporting/reconciliation deadline is approaching – confirm the date with your FMC representative. Please be sure you complete all necessary steps on time and your VMS data is up-to-date for accurate program tracking. Contact your FMC representative with any questions.

## **Updated Guidance on Payment Standards**

On September 30, 2024, we published <u>Notice PIH 2024-34 - Updated and</u> <u>Consolidated Policy Guidance on Housing Choice Voucher (HCV) Program Payment</u> <u>Standards,</u> providing new guidance to PHAs on payment standards, including regulatory changes implemented through HOTMA (Housing Opportunity Through Modernization Act of 2016), Small Area Fair Market Rents (SAFMRs), and exception payment standards. This Notice establishes a new process for establishing exception payment standards up to 120% of the FMR. PHAs that were approved under the previous streamlined approval process to implement payment standards greater than 110% up to 120% of the FMR that would like to continue with those higher payment standards must follow the new notification process outlined in this new notice, specifically section 5B.

### **HOTMA Income and Assets Update on Compliance**

On September 18, 2024, General Deputy Assistant Secretary Dominique Blom emailed PHA Executive Directors with updated information on the compliance date for the income and assets provisions of HOTMA (HOTMA Sections 102 and 104). The email announced that PHAs will not have access to the HOTMA-compliant HUD-50058 in HIP, which is required for compliance with certain HOTMA income and assets provisions, by January 1, 2025, and that HUD will soon issue additional guidance on HOTMA Income and Assets implementation.
