Mainstream Notice Describing New Alternative Requirements and Optional Waivers

On August 20th, HUD published Notice PIH 2024-30, "Statutory and Regulatory Waivers for Mainstream Vouchers." Using authority received from the Consolidated Appropriations Act of 2024, the Notice establishes new alternative requirements and optional waivers for Mainstream Vouchers that are intended to help PHAs improve Mainstream utilization and more successfully target Mainstream-eligible populations. PHAs have 120 days from the date of publication to implement the new alternative requirements. HUD will be hosting a webinar in Fall 2024 to provide a detailed description of the Notice. FY 2025 Fair Market Rents

On August 14, HUD announced FY 2025 Fair Market Rents (FMRs) in the <u>Federal Register</u>. The FY 2025 FMRs are effective October 1, 2025.

Revision to Implementation of NSPIRE Administrative Procedures for the Housing Choice Voucher Programs Published, Extends Compliance Date for Voucher Programs Until October 2025

HUD published revised notice <u>PIH 2024-26</u>, <u>REV-1</u> on August 9, 2024. It finalizes the administrative procedures of National Standards for the Physical Inspection of Real Estate (NSPIRE) for the Housing Choice Voucher (HCV) and Project-Based Voucher (PBV) programs. With the July 5, 2024, Federal Register notice <u>"Economic Growth Regulatory Relief and Consumer Protection Act: Implementation of National Standards for the Physical Inspection of Real Estate (NSPIRE); Extension of NSPIRE Compliance Date for HCV, PBV and Section 8 Moderate Rehab and CPD Programs, HUD announced the further extension of the compliance date for HCV and PBV programs until October 1, 2025. This notice applies to all Public Housing Agencies (PHAs), including Moving-to-Work (MTW) PHAs, administering Section 8 Housing Choice Voucher programs. PHAs were previously required to notify HUD if they were delaying implementation of NSPIRE anytime past October 1, 2023.</u>

 With this new extension, only PHAs that decide to implement NSPIRE prior to the new compliance date of October 1, 2025 (or change from early implementation to full extension date), must notify HUD of the date on which they plan to transition to NSPIRE.

FUNDING OPPORTUNITIES

Family Unification Program NOFO - Applications due October 30, 2024

PIH published the <u>FY 2024 Family Unification Program (FUP) Notice of Funding Opportunity</u>, due on October 30, 2024. The NOFO makes available \$5 million for new FUP vouchers for PHAs that partner with public child welfare agencies and Continuums of Care. FUP vouchers may be used to serve two populations: (1) families for whom the lack of adequate housing is a primary factor in (a) the imminent placement of the family's child or children in out-of-home care, or (b) the delay in the discharge of the child or children to the family from out-of-home care and (2) youth at least 18 years and not more than 24 years of age who have left foster care, or will leave foster care within 90 days, in accordance with a transition plan described in section 475(5)(H) of the Social Security Act, and are homeless or at risk of becoming homeless at age 16 or older.
