Richard J. Monocchio Sworn in as HUD's Principal Deputy Assistant Secretary for Public and Indian Housing



On May 22, 2023, Richard J. Monocchio was sworn in as the HUD's Principal Deputy Assistant Secretary for Public and Indian Housing. Rich brings over 30 years of housing experience to PIH and a deep commitment to connecting people to their communities and connecting communities to opportunities.

Rich most recently served as the Executive Director of the Housing Authority of Cook County (HACC) in Illinois. Before joining HACC in 2011, he served as First Deputy Housing Commissioner and Building Commissioner for the city of Chicago under the Daley administration, worked at HUD under the Clinton administration, and served as senior advisor to the late U.S. Rep. George E. Sangmeister from 1989 to 1994.

Among his other notable positions, he has served as

the vice chairperson for the Community and Economic Development Association of Cook County and as a board member for both the Chicago Cook Workforce Partnership and the Cook County Land Bank Authority.

Rich is focused on addressing the challenges Public Housing Authorities face, including the need for more affordable housing, better access to capital, and supportive services dedicated to children as they grow in their communities. He is looking forward to meeting with you to discuss solutions to the issues that are most important to your agency and the households you serve.

HUD Launches New LGBTQI+ Youth Homelessness Initiative During Pride Month

On June 8, 2023, the White House announced that HUD is launching a new federal initiative to partner with local communities, service providers, and directly affected young people to address barriers to housing and shelter access for lesbian, gay, bisexual, transgender, queer, and intersex (LGBTQI+) youth. Nearly 40 percent of all youth experiencing homelessness identify as LGBTQI+, and these disparities are especially pronounced for transgender youth and other black and brown LGBTQI+ youth. In this new initiative, HUD will encourage communities to develop collaborative solutions to address the specific needs of LGBTQI+ youth experiencing homelessness and housing instability.

In the coming months, HUD will release a toolkit focused on best practices for supporting LGBTQI+ youth and Frequently Asked Questions that provide clarity about complying with the Equal Access Rule and Fair Housing Act. HUD will also launch a regular training series for communities and providers committed to improving their support for LGBTQI+ youth.

SYSTEM INNOVATION

Welcome to HUD's monthly progress update on our information technology modernization. In 2023, we are launching updated systems to improve the user experience, payment accuracy, and cybersecurity. The system improvements will also reduce PHA staff time and increase efficiency. We want to ensure PHA leadership and staff understand these changes and can successfully transition to the improved systems.

System Innovation Event for Software Vendors and Training Partners

On May 17-18, 2023, HUD hosted an event for over 100 software and training stakeholders on the upcoming rollouts of NSPIRE, HIP, and other information technology and policy initiatives. The two-day event was designed to build capacity among software vendors and training partners to support PHAs with upcoming changes resulting from these initiatives.

NSPIRE

The National Standards for the Physical Inspection of Real Estate, or NSPIRE, focus on the health and safety of residents. Beginning in July 2023, HUD will use these new standards when inspecting the public housing portfolio. Along with new standards, NSPIRE uses

enhanced technology to increase timeliness and transparency in the inspection process. The improved technology streamlines many aspects of the inspection process, including scheduling and coordination of inspections, visual verification during inspections, information flow and quality control after inspections, and appeals submission and tracking. Housing Information Portal (HIP)

The <u>Housing Information Portal (HIP)</u> will eventually replace IMS/PIC and reduce the administrative burden on PHAs for providing information to HUD. This month, the HUD HIP team will be contacting third-party 50058 software vendors regarding the status of their testing efforts on integrating with the HIP system. As needed, the HUD HIP team will hold technical troubleshooting sessions. If your 50058 software vendor has not provided HUD their contact information, they can do so by following the instructions on the <u>HIP Technical Information</u> webpage.

Operating Fund Web Portal

Recently HUD deployed the Quality Control (QC) submission module for HUD-52723/52722 in the Operating Fund Web Portal. The QC module provides HUD staff with the ability to review and recommend second level review by subject matter experts in HUD's Financial Management Division. The module also provides PHAs with the status of their submissions in real time and provides PHAs with full access to their historical and current data.

HUD annually conducts QC reviews of the submissions. HUD's QC process checks Operating Fund data for anomalies and non-compliance with Federal regulations. For questions about the Operating Fund Web Portal, please contact <u>opfundwebportal@hud.gov</u>.

Public Housing Occupancy: Agency Priority Goal

One of HUD's priorities is to maximize the reach of HUD's rental assistance programs by increasing the number of public housing units that are occupied. The current national occupancy rate is 94.79%, a slight increase from 94.78% last month, and continuing the upward trend since the beginning of the fiscal year. Our goal is to increase occupancy to

95.5% by September 30, 2023. We encourage you to take advantage of occupancy resources for PHAs, such as the <u>PHA Occupancy Webinar Series</u>.

HUD is committed to helping PHAs fully utilize their historic increase in HCV funding and excess reserves in 2023. To track progress, HUD has an Agency Priority Goal of spending 100% of the 2023 HCV funding by September 30, 2023. The national utilization rate began 2023 at 92.7%, but thanks to the great work of PHAs, the utilization rate is now 96%, an increase from 95% last month. FCC Announces Second Round of Affordable Connectivity Program Outreach Grants

The FCC recently announced a second round of funding for Affordable Connectivity Program (ACP) outreach grants under the <u>National Competitive Outreach Program (NCOP</u>), making up to \$5 million available for eligible governmental and non-governmental entities in certain States and Territories. Housing Mobility-Related Services – Applications Due August 30

The <u>Housing Mobility-Related Services Notice of Funding Availability (NOFO)</u> makes \$25 million available for PHAs to offer housing mobility-related services to address barriers to housing choice and increase the number of voucher families with children living in areas of opportunity. Housing Mobility-Related Services are services, financial assistance and incentives that help families move to opportunity areas. These include pre-move support and housing search assistance, landlord outreach and support, post-move and subsequent-move supports, as well as family financial assistance such as security deposit assistance and landlord financial incentives. Jobs Plus – Applications Due August 21

On June 6, 2023, HUD published the FY23 Jobs Plus Notice of Funding Availability (NOFO), making \$22.5 million available to PHA applicants to advance employment outcomes and increase earnings for residents of public housing. This place-based program incentivizes and enables employment through earned income disregards for working residents and services designed to support work, including employer linkages, job placement and counseling, educational advancement, and financial counseling. Applications are due August 21, 2023.

Capital Fund Grants for Receivership, Troubled, or Otherwise High-Risk PHAs – Applications Due August 21

This <u>Notice of Funding Opportunity</u> makes \$12.5 million available for PHAs in receivership, designated troubled or substandard, or otherwise at risk for capital improvements at public housing asset management projects (AMPs). Applicants will be competitively scored based on how the funding will improve physical condition and management to provide residents access to safe and decent public housing, increase occupancy, and reduce long-term vacancies through capital improvements. Applicants may submit one application with only one AMP, which may include multiple properties or scattered sites. Applications are due August 21, 2023.

Capital Fund Emergency Safety and Security Grants – Applications Due June 28

The <u>FY23 Capital Fund Emergency Safety and Security Grants Notice</u> makes \$10 million available for PHAs to install, repair, or replace capital equipment or systems that contribute to a safer living environment for residents. Please submit a PDF copy of the application (in one, single PDF file) with all applicable documents listed in Paragraph 5 of the Notice to <u>PIHOCI@hud.gov</u>. Birmingham Housing Authority Aims to Close the Digital Divide

The Housing Authority of the Birmingham District (HABD) in Birmingham, Alabama, was recently awarded a *Your Home, Your Internet* grant from the Federal Communications Commission (FCC). The grant will allow the housing authority to help more households receiving federal housing assistance learn about and enroll in the FCC's <u>Affordable</u> <u>Connectivity Program (ACP)</u>, a benefit that provides low-income households up to \$30 per month for internet service.

Because HUD-assisted households are enrolling in the Affordable Connectivity Program (ACP) in lower numbers than other eligible households, the FCC launched the *Your Home, Your Internet* grant program to promote outreach and enrollment strategies that can successfully drive ACP uptake among HUD-assisted households. HABD was one of twenty-three PHAs to receive an award.

Prior to winning this award, HABD was already working to narrow the digital divide. HABD joined HUD's <u>ConnectHomeUSA</u> initiative in 2018. Since that time, the housing authority has worked with the city and other local organizations to bring affordable internet connectivity and devices to residents. When the ACP became available, HABD proactively informed residents about the benefit. In November 2022, HABD registered more than 100 households for the ACP through Birmingham's Connect99 campaign, which aims to close the digital divide in all of Birmingham's 99 neighborhoods. Now, with the support of the FCC's *Your Home, Your Internet* grant, the housing authority can help more households enroll in the ACP.

"It's no secret that the digital divide disproportionately affects residents who are lowincome," said Dontrelle Young Foster, President and CEO of HABD. "Now, with the support of a grant of more than \$250,000, we look to continue our partnership with the city and EducationSuperHighway, expanding our efforts and registering even more eligible Birmingham families for the broadband benefit."

HUD's ConnectHomeUSA initiative has supported 100 PHAs and tribes in their efforts to narrow the digital divide in their communities. HUD's national nonprofit partner, <u>EducationSuperHighway</u>, is not only working closely with ConnectHomeUSA PHAs like HABD, but also has developed ACP-related tools and training for all PHAs:

- ACP Pre-Enrollment Tool for Residents: Residents can use EducationSuperHighway's ACP pre-enrollment tool to determine what documentation they need to demonstrate eligibility for the ACP: <u>getacp.org</u>.
- ACP Enrollment Training Course for PHAs: PHAs can use EducationSuperHighways's free <u>training course</u> to equip their staff and partners to support households to enroll in the ACP and sign up for a high-speed home internet plan.

Research from the Pew Research Center <u>shows</u> that in 2021, 43% of adults with annual household incomes under \$30,000 did not have broadband internet at home, compared with just 8% of those earning \$75,000 or more. The Affordable Connectivity Program is making a difference. As of May 2023, more than 18 million households are enrolled in the ACP.

Broadband is a necessity for all households, yet many HUD-assisted families lack access to reliable, affordable, high-speed internet. Through our partnerships with the FCC, other federal agencies, and the national nonprofit EducationSuperHighway, HUD is committed to helping PHAs increase internet access for work, school, health care, and other essential services among the households we serve.
