### PDAS Monocchio on the Road

#### PDAS Monocchio Visits PHAs in North Carolina

Last week PDAS Rich Monocchio visited Charlotte, Greensboro, and Durham to see the innovative and essential work that PHAs in North Carolina are doing to increase the supply of affordable housing and support residents in HUD-assisted housing.

While in Charlotte, he met with leadership at INLIVIAN and toured development sites including the newly developed Gaston at North End, the Landing at Park Road, and Trella at Uptown, a 353-unit mixed-income development currently being built in one of Charlotte's most popular neighborhoods.

In Greensboro, PDAS Monocchio toured the new affordable housing development Townsend Trace; senior housing Smith Homes; and Willow Oaks, a neighborhood with opportunities to build affordable single- and multi-family housing on city-owned land.

While in Durham, PDAS Monocchio joined a roundtable discussion on the need for affordable housing and the importance of resident-centered community development as the city transforms 60 acres of publicly owned land downtown with a shared redevelopment vision.

Remarking on the trip, PDAS Monocchio said, "Touring new developments, meeting with PHA leadership, talking with community developers, and most importantly, listening to residents is a priceless opportunity for me. If there's one thing I take away from visits like this, it's the reminder that there are so many emotions and aspirations tied to the work we do. We have to get it right. I'm heartened by the dedication I've seen from our partners in North Carolina. I sincerely appreciate their hospitality and the thoughtfulness and care they bring to the work of serving families and building communities."

### **Messages from PDAS Monocchio**

#### **New Source of Income Website (3-13-24)**

This week HUD published a new web-based resource to address Source of Income (SOI) discrimination. Source of Income discrimination is commonly known as the practice by landlords, property owners, and real estate brokers of refusing to rent to current or prospective qualified tenants with a Housing Choice Voucher or other forms of public assistance. HUD's new <a href="Source of Income Protections">Source of Income Protections</a> website serves as a "one-stop shop" for HUD stakeholders that summarizes existing

materials to explain the concept of SOI discrimination, identifies states and local jurisdictions that prohibit it, and provides resources for people who believe they have experienced this form of discrimination. The website includes guidance and resources for tenants with housing vouchers and for PHAs that administer voucher programs on what to do if Source of Income discrimination occurs, as well as strategies to reduce it.

#### **Updates on HIP and HOTMA Implementation (2-23-24)**

PDAS Monocchio provided updates on the Housing Information Portal (HIP), which is required for full HOTMA implementation. The update reiterates that compliance with the final HOTMA rule requires access to HIP, and that PHAs need the revised HUD-50058 in HIP to implement the income and asset requirements in Sections 102 and 104 of HOTMA. An FAQ accompanying the letter explains what actions PHAs can take now to prepare for HOTMA compliance without using HIP, and resources for PHAs to support HOTMA implementation.

### **Special Topics**

### **FY24 Budget**

On March 9, 2024, the President signed the <u>2024 Consolidated Appropriations Act</u> appropriating \$43.2 billion to HUD's Office of Public and Indian Housing (PIH), approximately 60% of the Department's \$75.7 billion budget. Here are some of the highlights:

HOUSING CHOICE VOUCHER PROGRAM: The Tenant Based Rental Assistance (TBRA) program received \$32.4 billion, an increase of \$2.1 billion from 2023. The Housing Assistance Payment (HAP) program received \$28.5 billion, and Administrative Fees received \$2.8 billion. The appropriation also provides \$15 million for the HUD-VASH program.

PUBLIC HOUSING FUND: The 2024 Minibus provides \$8.8 billion for the Public Housing Fund, an increase of \$296 million from 2023. This funding level provides \$5.5 billion for Operating Fund formula grants (100% proration), \$3.2 million for Capital Fund formula grants, and \$25 million for Operating Fund shortfall prevention. To further support public housing investments, the appropriation provides \$15 million for Troubled, At-Risk PHAs, including PHAs under receivership or monitorship, and \$65 million for Housing Health Hazards and Lead Paint Testing and Abatement. In addition, Emergency and Disaster Grants received \$30 million, including \$10 million for Safety and Security grants.

<u>SELF-SUFFICIENCY PROGRAMS</u>: The Self-Sufficiency Programs received \$195.5 million, an increase of \$20.5 million from 2023. The Family Self-Sufficiency program received \$140.5 million, the Jobs Plus program received \$15 million, and the Resident Opportunities and Self-Sufficiency (ROSS) program received \$40 million.

<u>CHOICE NEIGHBORHOODS</u>: The Choice Neighborhoods program received \$75 million to transform, rehabilitate, and replace both public and HUD-assisted housing and to transform neighborhoods of poverty into functioning, sustainable mixed-income neighborhoods with appropriate services, schools, public assets, transportation, and access to jobs.

### **Urgent Cybersecurity Alert and Resources to Mitigate Future Threats**

This week, the FBI asked federal agencies to share an urgent <a href="Cybersecurity">Cybersecurity</a>
<a href="Advisory">Advisory</a> detailing a potentially serious security threat for organizations using
<a href="Ubiquiti EdgeRouters">Ubiquiti EdgeRouters</a> and the <a href="Threat Intelligence Technical Details">Threat Intelligence Technical Details</a> outlining the steps necessary to mitigate the threat.

HUD's Office of the Chief Information Security Officer and our partners at the Cybersecurity and Infrastructure Security Agency (CISA) would like to take this opportunity to remind PHAs of resources currently available to help you assess and mitigate future threats. The Multi-State Information Sharing and Analysis Center (MS-ISAC) is a free platform offering threat intelligence, detection, and response assistance through a collaborative data-sharing community. CISA's State and Local Cybersecurity Grant Program helps eligible entities address cybersecurity risks and threats to information systems, and CISA's Cyber Resilience Review is an interview-based assessment to evaluate an organization's operational resilience and cybersecurity practices. Finally, PHAs are encouraged to review additional resources available at CISA's Free Cybersecurity Services and Tools page.

### **Build America, Buy America Act Request for Information**

Last month, Principal Deputy Assistant Secretary Rich Monocchio sent a <u>message</u> regarding the <u>Build America</u>, <u>Buy America</u> (<u>BABA</u>) <u>Act</u> going into effect for public housing. To get your valuable feedback about specific challenges that PHAs will face in implementing BABA, HUD posted a <u>Request for Information</u>. Comments are due by April 15, 2024.

#### **New IRS Direct File Tool**

**IRS Direct File** pilot is a free, mobile-friendly tool for filing taxes built by the IRS. It is available in English and Spanish with live in-app customer service.

During this pilot year, eligibility is limited to taxpayers with simple tax situations in twelve participating states. Participants will be screened by Direct File to make sure

they are eligible before they invest the time in preparing a return, but general eligibility requirements are:

- they have income from an employer, Social Security, unemployment insurance, or investment *income of less than \$1,500*;
- they can claim the Child Tax Credit and the Earned Income Tax Credit;
- Live in a participating state—California, Arizona, New York,
   Massachusetts, Florida, New Hampshire, Nevada, South Dakota,
   Tennessee, Texas, Washington, and Wyoming.

Individuals can check their eligibility to participate in the pilot by visiting the <u>Direct</u> File eligibility checker.

### System Innovation

### **Housing Information Portal (HIP)**

PIH continues to work with IT vendors and PHAs' software vendors to finalize the implementation strategy for HIP and expects to release news about the strategy soon. PIH is also creating the HIP Implementation Notice, which will provide the schedule for implementation and necessary information to assist PHAs and their vendor partners in successfully converting to HIP.

PHAs or vendors who build 50058 software can sign up for the mailing list or find additional technical information on the <u>HIP Technical Information page</u>. The mailing list does not apply to PHAs seeking general information about HIP.

### **Enterprise Voucher Management System (eVMS)**

To ensure that eVMS best suits the business needs of our PHA partners, PIH has invited a group of PHAs to participate in a monthly focus group that will discuss how PIH can improve and enhance the PHA user experience in future eVMS development activities. As the group begins its work, we are happy to report that eVMS successfully calculated March Housing Assistance Payments (HAP) for 101 PHAs using their available PIC 50058 data. As a reminder, additional eVMS information including the Wave 1 Onboarding Webinar can be found on the eVMS website. We encourage all PHAs to actively review and utilize the PIC Error Dashboards to help get ready for migrating to eVMS.

**Public Housing Portal (Formerly Operating Fund Web Portal)** 

The Operating Fund Quality Check (QC) submission module for 2024 will be available in the Public Housing Portal on March 19, 2024. Submissions are due by April 2, 2024.

To support our PHAs with QC submissions, PIH has scheduled two QC Submission training sessions for the Public Housing Portal. The training sessions will review QC items and affected Asset Management Projects, how to create a QC-related submission, and how to update submissions for HUD Field Office review. These sessions will provide PHA staff with the opportunity to engage with the modules firsthand and ask questions. The content for both trainings will be the same, so you can choose which one to attend. A user guide and training video are available for reference on the Public Housing Portal website.

### **Public Housing Occupancy: Agency Priority Goal**

One of HUD's top priorities is to maximize the reach of HUD's rental assistance programs by increasing the number of public housing units that are occupied. Our current national occupancy rate is 94.72%. Our goal is to reach a national occupancy goal of 96% by September 30, 2024.

PIH has created several data dashboards to share real-time data on public housing occupancy and to support our shared goal of improving occupancy. We encourage you to take advantage of these data tools. If you have questions, please reach out to your local PIH Field Office.

# **Emergency Safety and Security Grant Program FAQs and Webinar Recording**

FY 24 Emergency Safety and Security Grant (ESSG) applications are due on March 27, 2024. HUD recently held a second ESSG webinar to provide additional

guidance on submitting applications. Updated FAQs, which include more detail on NSPIRE eligible work items for ESSG, are also available. You can find the recorded webinars and FAQ on the ESSG webpage.

### **Public Housing Waiting List Numbers Due March 31**

The Public Housing Waiting List module in the Public Housing Portal is **open until March 31, 2024**. This module opened January 1, 2024 and so far, *only 40% of PHAs have submitted their data.* All PHAs with a Public Housing Program must report the total number of families on the PHA waiting lists as required by Section 103 HOTMA (See Notice PIH 2023-03 for more information about these reporting requirements.

Under the <u>Capital Fund Financing Program (CFFP)</u>, a PHA may borrow private capital to make improvements and pledge – subject to the availability of appropriations – a portion of its future year annual Capital Funds to make debt service payments for either a bond or conventional bank loan transaction. This webinar will detail the process for submitting a successful CFFP proposal and give examples of how PHAs have successfully used CFFP transactions. ### **HUD-VASH Designated Service Provider Guidance**

The Department of Veteran Affairs (VA) and HUD have a previously established process for Designated Service Providers (DSPs) to act in the place of VA for the purpose of intake, referral, and case management in the HUD-VA Supportive Housing (HUD-VASH) program. Designation is done through the VA's HUD-VASH Collaborative Case Management Model (CCM). The DSP is typically a CoC-funded service provider in the community. Guidance on the CCM process for designation can be found on the VA website.

Guidance for how PHAs can apply to become a DSP for the specific purpose of intake and temporary case management prior to referral to the VA is now available. This flexibility allows PHAs to assist overburdened VA Medical Centers (VAMC) to serve eligible veterans in their area. Please note there is no additional funding for PHAs wishing to serve in this role. Application materials and more information may be found at the VA website.

# The Affordable Connectivity Program Is Expected to Wind Down in April

The Federal Communications Commission (FCC) issued a <u>notice</u> announcing that full funding to reimburse all current subscribers of the Affordable Connectivity Program (ACP) will end on April 30, 2024. Over 1.9 million residents of HUD-assisted housing have signed up for this program. PHAs should notify their residents to contact their local Internet Service Provider (ISP) to find out how their accounts will be handled once the ACP ends. There are <u>consumer protections in place</u> – for example, ISPs are not permitted to charge termination fees to ACP subscribers who may have signed up for an extended service plan.

HUD's nonprofit partner, EducationSuperHighway, has developed a <a href="https://example.com/household">household</a> <a href="https://example.com/household">checklist</a> to guide residents through the conversion process and a <a href="flow chart">flow chart</a> that explains the process.

### **Internal Revenue Service Elective Pay Office Hours**

The Inflation Reduction Act (IRA) makes several clean energy tax credits available to businesses; tax-exempt organizations; state, local, and tribal governments; other entities; and individuals. The IRA also enables entities to take advantage of certain clean energy tax credits through its elective pay provision (also colloquially known as direct pay). Elective pay allows several types of entities, such as tax-exempts and governments, to treat the amount of certain credits as a payment against tax on their tax returns and as a result receive direct payments for certain clean energy tax credits. Elective pay allows PHAs to take advantage of Clean Energy tax credits in the form of rebates. The IRS is hosting upcoming office hours for direct pay applicable entities that have questions specifically about the pre-filing registration process.
