### Messages from PDAS Monocchio

Principal Deputy Assistant Secretary Rich Monocchio recently sent the following messages to PHA Executive Directors. Visit [PIH News for PHAs](#) to view other archived messages.

#### [\*\*Update on NSPIRE for HCV and PBV Programs \(06-14-24\)\*\*](#)

PDAS Monocchio announced an extension to the compliance date for NSPIRE-V for one year, until October 1, 2025. In light of the extension, PIH will re-issue the NSPIRE-V notice with updated information.

#### [\*\*Responding to Extreme Heat in Public Housing \(06-13-24\)\*\*](#)

PDAS Monocchio announced the publication of [Notice PIH 2024-20](#), which includes guidance that PHAs may choose to provide assistance to any family in public housing that requests relief for excess utility charges for in-unit cooling during periods of severe or extreme heat. The increased costs of providing this relief are legitimate operating subsidy expenses. Although families must still request relief, the notice shows how PHAs can streamline the request process and includes sample language PHAs can use to start providing relief immediately.

## Expediting Admission to the Housing Choice Voucher, Project-Based Voucher, and Public Housing Programs for Persons Experiencing Homelessness

PIH published [Notice PIH 2024-17](#), which provides a streamlined process for PHAs to request waivers that will expedite housing assistance for people experiencing homelessness by enabling PHAs to accept self-certification of income, date of birth, and disability status for those who do not have documentation readily available. When granted, these waivers will remain in effect for a period of 12 months following approval and will provide alternative requirements that the PHA must follow during the period the waiver is in effect.

## Nominations for Members for the HUD Housing Counseling Federal Advisory Committee Due July 15

HUD published a [Federal Register Notice](#) announcing the nominations for appointment to the Housing Counseling Federal Advisory Committee (HCFAC). Nominations are due by July 15, 2024, and may be made by agency officials, members of Congress, the general public, professional organizations, and the nominee. Nominations to the HCFAC must be submitted using [form HUD-90005](#) and sent to [HCFAC.application@hud.gov](mailto:HCFAC.application@hud.gov).

The HCFAC provides the Office of Housing Counseling with advice regarding its mission to provide individuals and families with the knowledge they need to obtain, sustain, and improve their housing through a strong national network of HUD-approved housing counseling agencies and HUD-certified counselors. ## Public Housing Program

### Radon Demonstration Grant Applications Due July 15

Over \$4M in funding is available to protect children and families living in public housing from radon exposure. [Applications](#) are due by July 15, 2024. The funds cover testing and mitigation, as well as the development of a plan for future testing and mitigation as needed. The maximum award amount is \$600,000. ### Capital Fund NOFO for High-Risk, Receivership, Substandard, Troubled PHAs – Application Webinar Recording Available

Applications are due July 23, 2024. The NOFO makes \$12.5 million available to PHAs in receivership, designated troubled or substandard, or otherwise at risk to improve the physical conditions and management of public housing to provide residents access to safe and decent homes, increase occupancy, and reduce long-term vacancies through capital improvements.

## 2024 HUD-VASH Registration of Interest Open Until August 30

PIH is accepting registrations of interest until August 30, 2024, for new HUD-Veteran Affairs Supportive Housing (HUD-VASH) vouchers under [PIH Notice 2024-18](#). Approximately \$78 million is available for new HUD-VASH vouchers. The HUD-VASH program is a critical tool to help end veteran homelessness, combining Housing Choice Voucher (HCV) rental assistance for homeless veterans and their families with case management and clinical services provided by the VA at its medical centers (VAMC) and community-based outpatient clinics (CBOCs) or by VA contractors and VA designated entities.

### Home Energy Rebate Program Updates

The Department of Energy's (DOE) Home Energy Rebate Programs, including [Home Efficiency Rebates](#), are becoming available as states finalize their programs. Some of these rebates are point-of-sale for purchases such as heat pumps, hot water heaters, and electric ovens/stoves. DOE posts regular updates to their [website](#) about each state's process. ### Application for 2024 Low-Income Communities Bonus Credit Program Open until July 27

The application period for DOE's [Low-Income Communities Bonus Credit Program](#), also known as 48(e), is open for an initial 30-day period until July 27, 2024. Following the 30-day period, DOE will accept applications on a rolling basis. This program allows PHAs to get an additional 20% Tax Credit eligible for Elective (Direct) Pay on top of the existing 30% credit for placing small-scale solar and wind facilities on a PHA property.
