HUD Bridging the Wealth Gap

Today, HUD <u>announced</u> the release of *Bridging the Wealth Gap: An Agenda for Economic Justice and Asset Building for Renters*, which describes actions the department will take to help low-income renters achieve financial well-being and homeownership. 2022 FSS Notice Of Funding Opportunity

HUD has published the <u>2022 Family Self-Sufficiency NOFO</u> for PHAs to support the salaries of FSS Program Coordinators. Applications are due Monday, October 3, 2022. FSS Program Coordinators build networks with local stakeholders, conduct outreach to prospective participants, and support participating families in developing strategies to increase their earned income and make progress toward their employment and financial goals.

HUD's Carbon Monoxide Device Requirement - Government Purchasing Program

PHAs preparing for the new carbon monoxide requirements enacted by Congress must have carbon monoxide alarms or detectors installed by December 27, 2022. Carbon monoxide devices can be combined with smoke detectors, hard-wired or battery-operated. PHAs purchasing in bulk can consider Lowe's partnership with OMNIA Partners to provide government agencies and nonprofits contract savings at the time of purchase, with no minimum order required. PIH Notice 2022-01 includes more information about HUD's carbon monoxide requirement.

Louisville's Choice Neighborhoods Grand Opening Highlights Community's Transformation

Vibrant mixed-income housing, stunning placemaking art, an award-winning restaurant, high quality childcare, and new retail. Seven years ago, when a Choice Neighborhoods Planning Grant was awarded to the Russell neighborhood, most wouldn't have imagined these words could describe their community. But at a <u>July grand opening event</u> celebrating Phase III of what will be 620 mixed-income apartments, the results of a community-driven transformation were on full display.

In the 1940's and 1960's, urban renewal devastated the thriving African American business district and saturated the once diverse area with large, subsidized housing developments. One of these developments included Beecher Terrace, a deteriorated complex of 758 public housing units. In the decades since, the Russell neighborhood struggled with disinvestment and concentrated poverty.

But a community process – led by local champions with Choice Neighborhoods funding – changed that. Starting with a FY 2014 Choice Neighborhoods Planning Grant, the Louisville Metro Housing Authority, Louisville Metro Government, resident leaders, and their partners led dozens of community meetings. Beecher Terrace residents and community members developed "Vision Russell," a plan for the neighborhood's future. In 2016, the community received a Choice Neighborhoods Implementation Grant to make their plan a reality.

By July's grand opening event, over 400 new mixed-income units had been built or were under construction, replacing the old Beecher Terrace with revitalized low income, moderate income, and market rate units. Additional affordable housing units are being built in and outside of the neighborhood, including in opportunity-areas, replacing all former Beecher Terrace units one for one. Beyond housing, Choice Neighborhoods funds and leverage have sparked a multitude of neighborhood improvements. New retail centers include an award-winning restaurant, high quality childcare, and other neighborhood businesses. Beautiful murals reflecting the rich history of the neighborhood cover overpasses that were once eye sores. Dozens of homes along a key corridor received needed repairs. Bus stops have become works of art and a splash pad and new amenities dot the landscape.

Choice Neighborhoods provided the funds and convening power necessary for Louisville to create and implement a plan based on their unique assets and opportunities. What can your community create with Choice Neighborhoods funding? PHAs should consider applying for funding upon publication of the FY22 Choice Neighborhoods Implementation Grants Notice of Funding Opportunity later this summer / early fall.
