HUD Receives an A+ for FY 2022

For Fiscal Year (FY) 2022, the U.S. Department of Housing and Urban Development (HUD) is honored to receive an annual procurement scorecard rating of "A+," the highest grade available from the Small Business Administration (SBA). The annual Scorecard is an assessment tool that measures how well federal agencies reach their small business and socioeconomic prime contracting and subcontracting goals and reports agency-specific progress.

"Contracting with the federal government represents an important opportunity for small businesses," said HUD Secretary Marcia L. Fudge. "This achievement demonstrates HUD's commitment to partnering with small businesses and ensuring meaningful opportunities for the small business community to build America's economy."

SBA's Scorecard measures Federal agencies' success in meeting their overall small business contracting goals. The "A+" recognition represents significant accomplishments made by HUD to create contracting opportunities for small business concerns in all categories. For FY 2022, HUD exceeded its small business annual prime and socio-economic goals for Small Disadvantaged, Women-Owned, Service-Disabled Veteran-Owned, and HUBZone small businesses. The Department awarded 39.39% of total contracting dollars to small businesses, far exceeding the 23% goal for the federal government.

This achievement was due to the collaborative efforts of the program offices, the Office of the Chief Procurement Officer (OCPO), and the Office of Small and Disadvantaged Business Utilization (OSDBU) staff, and the Department's senior leadership. HUD recognizes there is more work to be done and remains committed to continually focusing its acquisition workforce and clients on changes in acquisition policies and regulations that impact small business utilization and programs. With its robust acquisition planning processes, the Department will continue identifying areas to maximize practicable opportunities for small businesses in contracting and advancing procurement equity.



Small Business is Everybody's Business at HUD

HUD seeks to maximize federal contracting opportunities for small and disadvantaged businesses, ensuring that small, small disadvantaged, 8(a), women-owned, Historically Underutilized Business Zone (HUBZone), and service-disabled veteran-owned small businesses are treated fairly and can better compete and win prime and subcontracting opportunities. Due to the joint efforts of the Office of Small and Disadvantaged Business Utilization, the Office of the Chief Procurement Officer, and HUD program offices, preliminary FY 2023 results show the Department awarded over \$467 million in prime contracts to small business concerns exceeding its annual small business prime goal. HUD also exceeded small business socioeconomic goals for small disadvantaged, women, service-disabled veteran-owned, and HUBZone owned businesses. HUD also increased its total dollar prime awards to small businesses in all categories from FY 2022. Below is a preliminary data pull from SAM.gov. The official scorecard from the Small Business Administration will be released in FY 2024.



Successful Outreach Events



As represented in the word cloud, FY 2023 was another year of successful outreach events. In FY 2023, HUD OSDBU hosted eight small business outreach events, including four annual events: 6th HUD IT Industry Day, 6th Women-Owned Small Business Outreach Event, 8th HUBZone Conference, and 6th Service-Disabled Veteran-Owned Small Business Outreach Event. The latter three events were held in-person. HUD OSDBU also hosted four "Live Chat with HUD's OSDBU" webinars: Understanding General Services Administration Multiple Award Schedule and Government wide Acquisition Contracts, Marketing to Government Agencies, Access Capital to Finance Growth, and Cyber Security. To continue outreach outside of the large events, on a monthly cadence, OSDBU hosts a virtual group meet and greet with interested vendors. OSDBU's outreach efforts reached more than 4500 vendors. In addition to HUD OSDBU organized events, HUD OSDBU also actively participates in external outreach events convened by other agencies, chambers of commerce, and associations. OSDBU reached over 4,000 small businesses across the country.

Although all Federal agencies release a Forecast, what makes HUD's Forecast a recognized best practice in the small business community is that it is updated monthly. The Forecast is one of several tools that help the small business community effectively market their goods and services to the cognizant components within the Department. In FY 2023, a new and improved Forecast will be available that allows users to easily filter the data by program office, NAICS code, contract type, dollar value and more.
