Extension to the Effective Date for Appraisal Review and Reconsideration of Value Policy and Associated Technology Updates

Today, the Federal Housing Administration (FHA) published <u>Mortgagee Letter (ML) 2024-16</u>, *Extension to the Effective Date of Appraisal Review and Reconsideration of Value (ROV) Updates,* to extend the implementation deadline of the provisions outlined in <u>ML 2024-07</u>, from September 2, 2024, to October 31, 2024.

FHA is extending the implementation deadline after careful consideration of industry feedback received following the ML publication on May 1, 2024. Major stakeholders provided compelling feedback that additional time is necessary to properly meet the new expectations of the ML due to staffing considerations, third-party coordination, and technology constraints. While the provisions outlined in <u>ML 2024-07</u> may still be implemented immediately, they must be implemented for FHA case numbers assigned on or after October 31, 2024. FHA's extension aligns with the effective date extension announced today by Fannie Mae and Freddie Mac.

As part of the implementation of <u>ML 2024-07</u>, the technology updates announced in <u>FHA INFO</u> <u>2024-43</u>, will also be available in <u>FHA Connection (FHAC)</u> beginning October 31, 2024.
