

Letter from the Field Office Director

Thank you for requesting the CT HUD Office's local publication, "Looking for HUD Associated Housing in CT." This publication has been designed to make it easier for you to identify and apply for HUD-associated rental housing. Originally, this book was designed solely for that purpose. However, over time we have found that people often need additional housing supports and rental options. Accordingly, you will find a variety of related information including contact information for other agencies that may be able to help you locate housing. You may wish to call 2-1-1 or access their website at www.211ct.org/, to view their database of affordable housing. In addition, the State of Connecticut maintains a website of state-wide housing opportunities which can be found online at www.cthousingsearch.org.

Are you in danger of being evicted?

Are you facing homelessness?

If so, please call United Way/ 2-1-1 instead of contacting HUD directly. In Connecticut, dialing 2-1-1 is the first step to get support, as HUD Offices do not provide housing directly. Please start by calling 2-1-1, pressing option 3 and then pressing option 1. You will be directly connected to a housing specialist who will provide you with the current shelter options and create an appointment for you with the local Coordinated Access Network or CAN. Through working with the CAN, your housing needs will be assessed, and staff will help you identify housing opportunities to match your needs as quickly as possible.

- If you are **under the age of 18** and are facing homelessness, please call 2-1-1 and press option 1. A housing specialist will help you find shelter in Connecticut. You may also call your town or city hall to find out about local youth shelters in your area.
- If you are a **veteran** facing homelessness, please refer to page 14 in this book or call the National Homeless Veterans Hotline (24/7) at 1-877-424-3838.
- Persons subject to domestic violence can call the statewide Domestic Violence Hotline at 1-888-774-2900 and/or their local police by dialing or texting 911, if subject to imminent violence.
- Individuals whose unit is not habitable, due to fire, flood or other emergency, need to contact emergency personnel for assistance. We have found that 2-1-1, the Red Cross and Salvation Army can often temporarily house people in these situations.

Do you think you have been a victim of housing discrimination?

Federal law prohibits housing discrimination based on your race, color, national origin, religion, sex, family status, or disability. If you feel you are a victim of discrimination you may file a complaint with HUD

The State of CT has additional protected classes and prohibits housing discrimination based on race, color, national origin, sex, ancestry, religion, family status, presence of children, mental or physical disability, marital status, age, sexual orientation, legal source of income, gender identity or expression. These complaints must be filed with the state. For more details please see pages 10-11.

Housing issues can be complex. We have prepared this guide as a resource to assist you in your search and would appreciate suggestions for improvements to this publication. The Department is very interested in working with organizations to expand the supply of affordable housing and would welcome calls from such groups interested in HUD's programs. How to Use the Guidebook

- 1. Look up the town where you may want to live. (Listings start on page 39)
- **2. Call the property agent or program** to ask about vacancies, eligibility, rents and application procedures. Property agents accept applications if the applicant can pay the rent and meet other requirements as listed in their tenant selection policy which is available upon request to any applicant. Apartments may have a rent subsidy to keep rents lower; the property agent can tell you if there is one available. Apartments with rent subsidy may have additional requirements. Generally, applicant(s) must:
 - (1) have an income at or below the maximum established income limit for the area,
 - (2) documents such as government photo ID, social security card, birth certificate, W-2 form, bank statement
 - (3) agree to pay the established rent.

Be advised that there may be long waiting lists at many properties, so you'll want to apply to as many places as possible.

- **3. Know your rights and responsibilities:** Federal law prohibits housing discrimination based on your race, color, national origin, religion, sex, family status, or disability. If you have been trying to rent a home or apartment and you believe your rights have been violated, you can file a fair housing complaint (pages 10-11). When you live in an apartment, you have both rights and responsibilities. Be sure you understand what's expected of you and what you can expect in return.
- **4. Housing Counseling:** HUD funds housing counseling agencies throughout the country that can give you advice on buying, renting, defaults, foreclosures and reverse mortgages. Things You Should Know

- HUD does NOT own or manage housing, nor does it take applications for housing.
- <u>Public Housing</u> is low-income housing, operated by your local housing authority

• The **Housing Choice Voucher Program** (Section 8) allows you to find your own unit using the voucher to pay for all or part of the rent. To apply contact your local housing authority (page 38).

Completing the Application

When you complete a rental application, you must include the following information plus any additional information required by the program for which you're applying.

Always request a copy of any forms you sign in when applying to a new unit or re-certifying.



Income

- All sources of money you or any member of your household receives (wages, welfare payments, alimony, social security, pension, etc.); including the names of all of the people (adults and children) who will abe living with you, whether or not they are related to you.
- Any money you receive on behalf of your children (child support, social security for children, etc.);
- Income from assets (interest from a savings account, credit union, or certificate of deposit, dividends from stock, etc.);
- Earnings from second job or part time job;
- Any anticipated income (such as a bonus or pay raise you expect to receive).

Assets

- All bank accounts, savings bonds, certificates of deposit, stocks, real estate, etc. that are
 owned by you and any adult member of your family's household who will be living with
 you.
- Any business or asset you sold in the last 2 years for less than its full value, such as your home to your children.

Signing the Application

- Do not sign any form unless you have read it, understand it, and are sure everything is complete and accurate.
- When you sign the application and certification forms, you are claiming that they are complete to the best of your knowledge and belief. You are committing fraud if you sign a form knowing that it contains false or misleading information.



• Information you provide on your application will be verified including and not limited to computer matches of the income you report with various Federal, State, or private agencies.

Recertification

- You must provide updated information as required. Some programs require that you report any changes in income or family/household composition immediately. Be sure to ask when you must recertify and what you must report on recertification forms.
- All income changes, such as increases and decreases of pay and/or benefits, change or loss
 of job and/or benefits, etc., for all household members must be reported as noted in your
 lease.
- Any move in or out of a household member
- All assets that you or your household members own and any assets that were sold in the last two years.

Beware of Fraud - You should be aware of the following fraud schemes:

- Do not pay any money to file an application;
- Do not pay any money to move up on the waiting list;
- Do not pay for anything not covered by your lease;
- Get a receipt for any payments and,
- Get a written explanation if you are required to pay for anything other than rent (such as maintenance charges).



Penalties for Committing Fraud

HUD places a high priority on preventing fraud. If your application or recertification forms contain false or incomplete information, you may be:

- ⇒ Evicted from your apartment or house;
- ⇒ Required to repay all overpaid rental assistance you received;
- \Rightarrow Fined;
- ⇒ Prohibited from receiving future assistance.

Section 8

The number of Section 8 vouchers is limited by federal funding. They are obtained by applying to individual housing authorities or the State of CT Department of Housing (through their contractor J.D'Amelia & Associates). All of these sources, however, have waiting lists, many of which are quite long. Most of the time, waiting lists are "closed," that is, they do not accept new applicants. Occasionally, however, a housing authority or the state will open its waiting list, usually for a fixed period of time, to accept new applications. Such openings are usually for two weeks or less and sometimes for as little as a single day. By state law, housing authorities must give at least two weeks' advance notice before a waiting list is opened. It is important to be aware of these notices and also to carefully follow each housing authority's directions for submitting an application.

- You can also register to receive electronic notice of the opening of Housing Choice Voucher waiting lists whenever they occur at www.cthcvp.org/
- Voucher holders find their own apartments and negotiate their own rents and leases with landlords. The landlord then signs an agreement with the housing authority that is administering the voucher. Each month, voucher holders pay their share of the rent (approximately 30% of income) to the landlord, and the housing authority pays the balance of the rent directly to the landlord.

Eligibility

To be eligible for a Section 8 voucher, a household's income must usually be less than 50% of the median income in the area, based on family size. The exact limits vary from area to area. There are also special categories of applicants for whom the income limit may be higher. Check with the housing authority to which you are applying to find out what its income limits are by voucher type.

Income Limits

HUD sets income limits that determine eligibility for assisted housing programs including the Public Housing, Section 8 project-based, Section 8 Housing Choice Voucher, Section 202 housing for the elderly, and Section 811 housing for persons with disabilities programs. If I get a Section 8 voucher in a particular town, do I have to move there?

Section 8 vouchers are "portable," which means that you can use them anywhere in Connecticut. In fact, you can use them anywhere in the United States. Local housing authorities, however, are allowed to put some limits on the portability of vouchers. The most important limit is that if you get a voucher from a town in which you are not presently living, the housing authority has the ability to require you to use your voucher only in that town for the first year that you have the voucher (after that you can move anywhere). Not all towns, however, impose this requirement. To find out if there is such a requirement, you must contact the local housing authority.

Discrimination

HUD's Office of Fair Housing and Equal Opportunity (FHEO) works to eliminate housing discrimination, promote economic opportunity, and achieve diverse, inclusive communities. Federal law prohibits housing discrimination based on your race, color, national origin, religion, sex, family status, or disability.

Connecticut law prohibits discrimination based on "source of income." State law applies to all housing except certain owner-occupied buildings. In CT, if the rent for the apartment is within Section 8 limits, you cannot be rejected because you will be paying with a Section 8 voucher.

Reporting Fraud

Abuse of HUD programs should be reported to HUD's Office of Inspector General (OIG) Hotline using one of three options below:

You must submit a statement in support of allegations of fraud, waste, abuse, and/or mismanagement. Information that is too vague or cannot be supported can result in a closed report, without any action taken.

Healthcare for Homeless Veterans

VA Connecticut's Healthcare for Homeless Veterans (HCHV) Program encompasses an array of services and service links for Veterans who are homeless, at risk of homelessness, under housed, or economically challenged. These services range from emergency shelter housing to transitional housing, to permanent supportive housing and HUD-VASH rental housing vouchers with clinical case management. The hallmark of these services is individually designed, intensive case management that allows the VA Homeless team to support our Veterans to meet not only their immediate housing needs, but also to pursue permanent housing.

The VA CT Homeless Program is made available to all Veterans, primarily through walk-in, National Homeless Veterans Hotline or direct referral. Homeless program staff outreach and engage Veterans who, if not currently engaged in VA services, can gain access to the full array of services offered by VA Connecticut. The Homeless team staff provides case management as well as supports for needy Veterans seeking basic needs, emergency shelter beds, transitional housing, and permanent housing.

HCHV Program Eligibility:

In general, eligibility for most Veterans' benefits is based on discharge from active military duty with honorable or other than dishonorable conditions. Some services may be available for Veterans who are ineligible for VA Healthcare. To gain access to HCHV services, Veterans must be:

- 1. Homeless or at risk of homelessness
- 2. Assessed and evaluated through outreach and intake with a HOMES Assessment interview
- 3. Meet income guidelines established by the Department of Veterans Affairs (for some services)
