Subject: Amendment to Notice 97-18, Modification of Mutual Help Contribution Drawdown Procedures in LOCCS, issued April 21, 1997

- 1. <u>Purpose:</u> This Notice amends the policies and procedures issued in Notice 97–18. All pertinent information is repeated in this Notice; therefore, Notice 97–18 should be discarded. This Notice modifies the policies and procedures for the drawdown of Mutual Help Contribution funds from the Line of Credit Control System Voice Response System (LOCCS-VRS) for Indian Housing projects.
- 2. <u>Background</u>: As a condition of occupancy, a Mutual Help homebuyer is required to provide a Mutual Help Contribution. When an Indian housing authority's development project reaches the Date of Full Availability (DOFA), the Mutual Help Contribution is credited to the homebuyer's account and retained by HUD. After DOFA, the Mutual Help Contribution may only be drawn down from LOCCS-VRS to cover a debit balance in the Monthly Equity Payment Account (MEPA) for a vacated unit, to the extent of the credit balance in this account, or to supplement the homebuyer's equity account, typically at time of purchase of the home. In order to simplify the administration of the Mutual Help Contribution and in anticipation of the programmatic changes which will occur with the implementation of the Native American Housing Assistance and Self-Determination Act of 1996, this Notice modifies the above policies and procedures to provide for the drawdown of the Mutual Help Contribution at the time of DOFA.
- 3. Applicability: All Mutual Help projects shall be covered by the provisions of this Notice.

4. Policy:

- a. Mutual Help Contributions of cash are not included in the drawdown procedures. Cash contributions are paid to the housing authority at the time of remittance by the homebuyer.
- b. Upon entry of the DOFA date, LOCCS-VRS will disburse all Mutual Help Contribution funds as approved on the current Development Cost Budget, form HUD-52484 or HUD-53045A.

- c. The Mutual Help Contributions disbursed will be accounted for using one of the following two methods.
- 1) For every unit not previously conveyed by the housing authority, and where funds have not been used to cover a debit balance in the MEPA for a previous participant, the Mutual Help Contribution should be used to supplement the amount in the equity account (24 CFR 950.440(e)(4)). Previously, this process took place at the time of conveyance.
- 2) Remaining funds should be included in the housing authority's proceeds from sale. These funds represent instances where the units have been conveyed by housing authorities; but the Mutual Help Contribution has not previously been drawn down.
- d. After conveyance of the home, the Mutual Help Contribution becomes part of the "proceeds of sale" and is eligible for loan forgiveness. The housing authority must continue to follow the procedures outlined in Notice 96–25, Indian Housing Homeownership Programs Loan Forgiveness Procedures. This includes the execution of the Consolidated Annual Contributions Contract (ACC) or a Loan Forgiveness ACC Amendment in order to authorize the housing authority to retain "proceeds from sale". Also, the use of "proceeds" will be governed by the procedures in Notice 96–25.

5. Procedure:

a. Housing Authority Responsibilities

- 1) Prior to DOFA, verify that the funds budgeted for Mutual Help Contributions on the latest approved development budget equals the correct number of units built times \$1,500. If corrections are necessary, submit a revised Development Cost Budget, form HUD-52484 or HUD-53045A.
- 2) Upon notification by HUD of the disbursement of Mutual Help Contributions funds to the housing authority bank account, record the accounting transactions as usual. Only the timing of the drawdowns are affected by this Notice.

b. Area Offices of Native American Program (ONAP)

- 1) For all Mutual Help projects with a DOFA date entered into LOCCS, verify and make necessary corrections to budget line item (BLI) 1503, Mutual Help Contributions, in LOCCS. All corrections must be complete 20 days from the date of this Notice.
- 2) On August 6, 1997, LOCCS will automatically disburse the balance of funds in BLI 1503 for all Mutual Help projects with a DOFA date in LOCCS. The area ONAP will receive a report listing the disbursement of Mutual Help Contribution funds. Within 5 workdays of receipt of the report, the Area ONAP must notify each affected housing authority of the amount of Mutual Help Contributions funds disbursed from each project. The Area ONAP may accomplish this task by providing a cover letter and a copy of the applicable section of the report to each housing authority.

3)	Upon notification of DOFA from an IHA, the date should be promptly entered into LOCCS.
	Entry of the DOFA will automatically create a voucher in LOCCS which will disburse the
	funds in BLI 1503. The Area ONAP must verify the amount of funds on the voucher and
	notify the housing authority of the scheduled date of disbursement and the amount of
	funds to be disbursed.
