New FHA Mortgagee Letter 2013-26 - Back to Work - Extenuating Circumstances:

As part of an ongoing effort to expand access to mortgage credit for families impacted by the recent financial crisis, FHA is providing guidance for underwriting borrowers credit who, but for economic circumstances brought on by the crisis, would be creditworthy. These policy announcements provide greater clarity and flexibility to lenders encouraging them to consider additional factors when evaluating a borrower's credit, ultimately supporting the recovery of the housing market and the economy. All applicants for this program must complete pre-purchase counseling from a HUD-approved housing counseling agency at least 30 days prior to submitting their application for a loan. Today, FHA provides policy guidance outlined in the following Mortgagee Letter and Housing Notice::

Subject: Back to Work - Extenuating Circumstances

This Mortgagee Letter (ML) provides guidance on minimum underwriting standards and guidelines for evaluating the credit of borrowers who have experienced an economic event related to job loss or reduced household income during the recent financial crisis. Because of these recent Recession-related periods of financial difficulty, borrowers' credit may have been negatively affected. FHA recognizes the hardships faced by these borrowers, and that their credit histories may not fully reflect their true ability or propensity to repay a mortgage.

Housing counseling is an important resource for both first-time home buyers and repeat home owners. Housing counseling enables borrowers to better understand their loan options and obligations and assists borrowers in the creation and assessment of their household budget, accessing reliable information and resources, avoiding scams, and being better prepared for future financial shocks, among other benefits to the borrower. For additional details related to housing counseling, refer to FHA Housing Notice 13-22 also issued today.
